## 2020 Teen Summer Camp Counselor Job Description



### **Overview:**

Silver Lake Nature Center is looking for an energetic and creative individual to teach our 2020 Summer Camp. This educator will work with the 13 to 17 year old campers. This is a nature-based camp that is both educational and fun. The camp itself will run for 9 weeks from June 22 to August 21, from 9:00 am to 4:00 pm with extended care. This position would be a full day from 8:30 am until 4:30 pm, Monday through Friday for the 9 camp weeks. Several of the weeks would require one overnight at SLNC and/or a day-trip off-site. Additional week of counselor training just prior to camp required, June 15 to June 19 from 9:00 am to 4:00 pm.

### **Duties and Responsibilities:**

- ✓ Keep calm during stressful situations
- ✓ Plan and implement lesson plans for the 13-17 year old age group
- ✓ Oversee and participate in environmental education programs for teenagers
- ✓ Help supervise campers and children during before care hours
- ✓ Supervise Counselors-in-Training (CIT's) assigned to your group
- ✓ Lead interpretative hikes on our trails, arts and crafts activities, and cooperative games and sports
- ✓ Maintain an organized and clean work space, including supply closets, office, and areas used by campers
- ✓ Be prompt with shift times, which are 8:30 am-4:30 pm Monday through Friday
- ✓ Be able to sleep overnight on Thursday night at SLNC for 3 of the 9 weeks
- $\checkmark$  Be able to return late on Thursdays of weeks 3 and 7
- ✓ Be present for all 9 weeks of camp
